



Horse Agistment Agreement

This Agreement is made the _____ day of _____ between Javarcy Park Equine, 511 Mary Ann Road, Echuca Victoria 3564 ('the Agistor') and _____ of _____ ('the owner') Whereby the Agistor agrees to agist the Owners horse identified below ('the horse') at the Agistment Property at 511 Mary Ann Road, Echuca Victoria Vic 3564 with the conditions set out below.

1. The Owner agrees to pay all the Agistor's agistment fees and other charges as detailed below, which will be payable on receipt of invoice.
2. The horse is at the Owners risk at all times. It is the Owner's responsibility to insure the horse and any progeny against all risks while they are at the Agistment property or being transported to and from the property. The Agistor shall not be responsible for any disease, accident, vice, illness or injury howsoever caused or arising to the horse whilst at the property or when transporting to or from the Agistment Property.
3. The Owner must notify the Agistor immediately the owner becomes aware that the horse suffers or has been in contact with any significant or notifiable sickness, disease or injury.
4. Veterinary services for the horse and/or progeny may be provided at the discretion of the Agistor in consultation with the Agistor's veterinarian. The Owner will pay all veterinary and other charges incurred while the horse is at the Agistment property.
5. The Owner gives the Agistor a lien over the horse and progeny for payment of the agistment fees and all other charges and expenses which the Owner must pay under this Agreement. This means that the Owner may not remove the horse or its progeny from the property while any part of this Agreement is not fulfilled.
6. The Agistor may sell the horse and/or its progeny at public auction or by private sale, to recover any monies unpaid for 60 days after the Agistor has sent the account. The Owner irrevocably appoints the Agistor as the Owners attorney with power to sell the horse and/or its

progeny and sign all transfers and other documents and do everything necessary to effect and complete the sale and to receive the purchase price and credit towards the cost of sale and all monies owing.

The services provided are as follows:

1. Paddocks;
 - a. The horse is allocated 2 paddocks, with at least one with shelter. Paddocks are fenced with electric wire.
 - b. Paddocks are regularly watered and harrowed to ensure the best possible pasture to cater for the needs of the horse. It is at the Agistors discretion when the horse is moved.
2. Water is provided via water troughs that are fed from our dam.
3. In the event of illness or injury, a veterinarian will be called to treat the horse.

Agistment fee/rate is \$12.50 (Full DIY) per day (inc gst) or \$25 (full Care). All feed needs to be supplied.

Not included in the agistment fees is:

1. Any training or education services
2. Daily rugging
3. Farrier service
4. Dentistry, Veterinary, Chiropractor etc
